Other matters

Since being Junior Proctor in 1984-5, then chairman of the Philosophy Sub-Faculty at the University of Oxford, and later chairman of the Literae Humaniores Board, I have been on numerous university committees, as well as college ones. I was a Curator of the Examination Schools from 1990-99. In college, since ceasing to be Senior Dean I have been convenor of the Panel of College Advisers (an alternative to the moral tutor system); have recently been on the Bursarial, Chapel and Choir, and Modernisation Committees (but am now off the first two); Wine Steward 1979-96, and acting again in that capacity from 2003.

From 1982 until about 1993 I was on the Management Committee of the Jan Hus Educational Foundation, which is concerned with promoting educational and cultural objectives in the Czech and Slovak Republics, and for much of the time I was on the Foundation's Executive Committee as well. I visited Czechoslovakia regularly in connection with the Foundation's activities, particularly in the 1980s, when I organised unofficial philosophy courses there as well as giving lectures. The courses were on Philosophical Logic, Kant, Aristotle's *Ethics*, and Descriptive Metaphysics; I gave lectures and seminars in each series.

From 1988 to 1992 I was on the Steering Committee of the Standing Conference for Arts and Social Studies (a national UK pressure group), and I returned to it in 1999 for a further three years.

In 1988-91 I spent quite a lot of time in preparing for publication a selection of letters of the Revd Thomas Twining (historian of music and translator of Aristotle's *Poetics*: 1734-1804), which my father had more or less completed before his final illness but which required extensive checking and some revision of notes. It was published, in two volumes, by the Edwin Mellen Press in 1991.

From 1999 to 2006 I was seconded full-time to the administration of Oxford University. I was able to keep up a small amount of teaching and research, but my University appointments did not really allow for it. In 2006 I returned to my duties as a Fellow and Tutor in Philosophy at Magdalen College, and a "Common University Fund Lecturer" in the University of Oxford.
