## INTRODUCTION

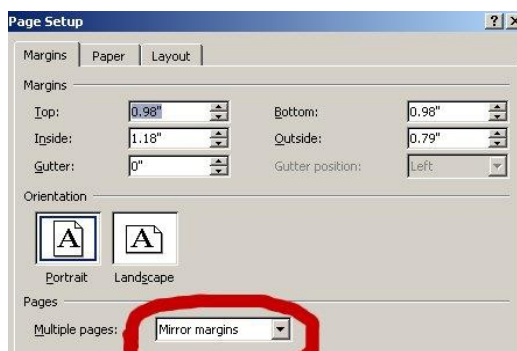


Fig. 1: Page setup in Word.

The abstract should be in one column (like this example) with length 2, 4 or 6 pages. Use A4 page set-up and make following format: top and bottom margin 2.5 cm (0.98 inch), inside margin 3 cm (1.18 inch) and outside margin 2 cm (0.79 inch). Set a portrait orientation, mirror margins and single line spacing (see Figure 1).

## EXPERIMENTAL SETUP

Use 12 pt Cambria font. Centre the title, the authors' names, the addresses, keywords and contact email address. Please compose a title that clearly and succinctly describes the content of your work. Ensure that Figures and Tables have captions and that they are numbered consecutively. Start each paragraph with an indent. Justify the body of the text both left and right. Do not use page numbers. Keywords are there to draw attention to your abstract, and to help the organizers allocate the presentation to the most appropriate session.

The text is divided roughly into the following subsections: Introduction, Experimental setup, Results, Conclusions, Acknowledgement and References. Titles of subsections are centered and in ALL CAPS format.

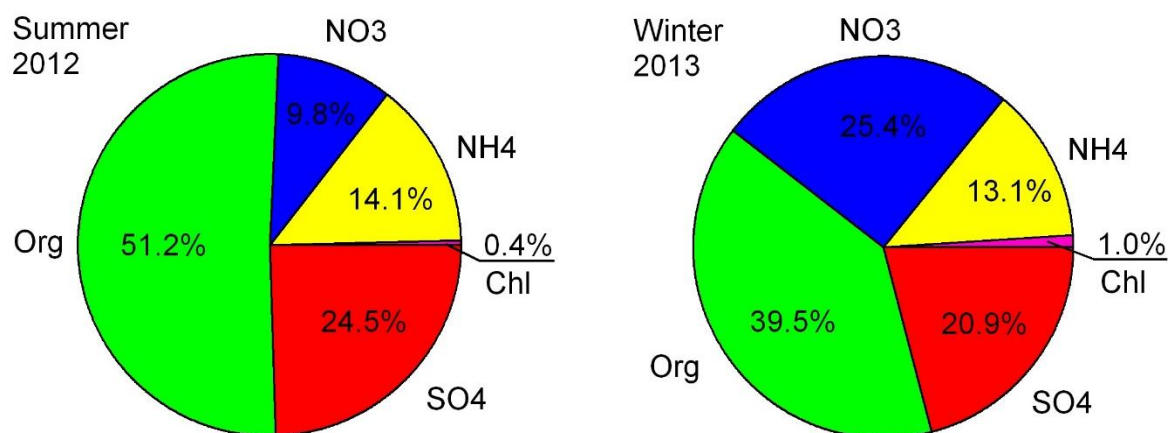


Fig. 2: An example of figure - an average relative composition of non-refractory aerosol.

## RESULTS AND CONCLUSIONS

Graphs are better like pictures (e.g. jpg, png) than in Excel format (see Figure 2). Font in graphs should be easy to read - not like in Figure 1 but rather like in Figure 2. Instead of use Word drawing, rather export schemes like pictures. Tables are only with horizontal lines. An example of an equation is here.
