Mapping perceptions of topophilia and topophobia using a mobile app: A tale of two cities

- Perceived topophilia is more pronounced than topophobia in both case studies
- In Brisbane, participants responded to app notifications more consistently than in Olomouc
- The occurrence of topophilic and topophobic perception fluctuates over time and space
- External conditions play a significant role in shaping perceptions of urban space
- An individual's activity spaces are often perceived ambivalently

Are Roma losing their roots? Traditional and non-traditional Roma occupations in two large communities in Romania: Timișoara and Cluj-Napoca

- Paper highlights significant correlation between Roma identity and economic activities
- Novel approach reveals traditional roles passed down through male generations
- Skills transfer from grandfather to father to son sustains Roma cultural heritage
- Insights into Roma economic integration and socio-economic state
- Economic differences based on the structure of Roma nations

Estimating required general practitioner capacity due to generational change in Czech regions up to 2035

- Current age structure of Czech physicians is unbalanced, the generational change is threatened
- Over one third of general practitioners and two thirds of pediatricians will leave the health system due to age by 2035
- Regional impacts are severe, with over 80% of current physicians retiring in some areas
- Future demand will also be affected by the changing age structure of patients
- Analysis results are crucial for key Czech healthcare stakeholders

An opportunity missed is an opportunity lost. Flood maps and their (non-)utilization by local government bodies in the Czech Republic

- Survey for flood maps use across local government bodies in the Czech Republic
- Local governments prefer traditional floodplain maps over newer types of flood maps
- Newer flood maps are rarely used despite being included in national legislation
- Flood maps are used mainly as technical tools, not for risk communication
- Incorporating local experience into maps remains underemphasized and underutilized

Cross-border cooperation of Polish and Czech area-based partnerships supported by Rural Development Programmes: Genuinely international or solely national projects?

- The EU Community-led Local Development (CLLD) supports Local Actions Groups (LAGs)
- The most active LAGs engage in cross-border and international cooperation projects
- LAGs cooperate in the field of education, promotion of local products and services
- National rules create an asymmetry in the scope and possibilities of cooperation
- Restrictions hamper the transfer of innovation and transnational European integration
