International Recognition

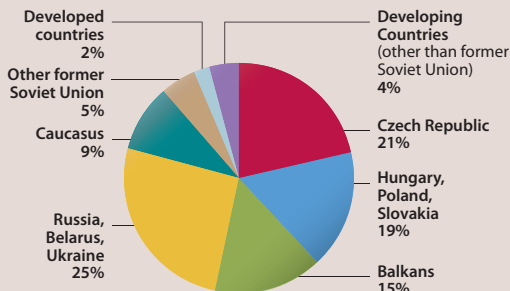

MAE Program

The Masters of Applied Economics (MAE) program is an intensive, empirically-based 12-month program that enables students to obtain an economic education typically not available in their home countries and gain the essential skills demanded by local and international employers.

- Practical orientation to prepare students for professional career with top-level positions in Economics, Finance, and other relevant fields
- Rigorous technical training designed to reflect the current economic conditions and employers' demand for specialists
- Combination of economic theory and application, professional communication, English skills, and real-world case studies

Duration: Full-time, 12 months

- 3 semesters and 2 breaks
- New entering class every September
- Preparatory session: in July-August in Economics and English (online or in person)

English Proficiency

- Internet-based TOEFL: minimum score 88
- IELTS: minimum score 6.5
- Or demonstrated equivalent English proficiency

Deadline

Applications accepted throughout the year.

Graduates receive a US degree. MAE program is chartered by the New York State Board of Regents.

Qualifications

- Bachelors degree or equivalent
- Masters graduates welcome
- Math skills an advantage
- Work experience not obligatory but considered an advantage

Tuition

- 12,000 euro for completed program
- **8,000 euro** for applicants from post-transition and developing countries
- **Scholarships:** up to 4,000 euro for exceptionally well-prepared applicants
