RESEARCH IN PROGRESS

Paper 1: "Political Parties and Wasteful Spending in Procurement: Evidence from the Entry at Electoral Thresholds,"

Abstract: "This paper present evidence that number of political parties in elected political entities matters for the extent of wasteful public spending. My identification strategy, which is suitable for any country with proportional elections, exploits a minimum requirement on the vote share of political parties for entering legislatures. Using a fuzzy regression-discontinuity design I compare legislatures where some parties barely exceeded or barely failed to exceed the electoral threshold. I find that legislatures with additional parties misallocate fewer procurements to suppliers who are the donors of political parties. Such legislatures also achieve higher price savings in procurement and increase procurement competition by making their procurements open for more bidders. The entry of extra parties leads to greater benefits in municipalities, where the incentives and opportunities for mutual monitoring among parties are stronger, such as in small legislatures, legislatures with few parties and legislatures in smaller municipalities."

Paper 2: "Manipulation of Procurement Contracts: Evidence from the Introduction of Discretionary Thresholds," (with Filip Pertold).

Abstract: "We present evidence of how policies that create opportunities to avoid open competition in procurement lead to the manipulation of procurement values. We exploit a policy reform in which public bodies were given the autonomy to preselect potential contractors below newly defined discretionary thresholds. Manipulation is revealed through bunching of procurements just below the thresholds in construction works and services, and less so in goods. Among the manipulated contracts we document a threefold increase in the probability that procurements are allocated to anonymous firms, which can hide the final beneficiary in the procurement. This sorting violates assumptions behind regression-discontinuity designs."

Paper 3: "Information and Vulnerability of Voting Rules to Strategic Voting,"

Abstract: "This paper explores voting behavior of individuals in committees and small collective decision-making organs. I use computation-based simulations to quantify the vulnerability of ten most common voting rules to strategic voting manipulation. I study how the ability of the strategic voter to swing the voting outcome into her favor changes when she loses full information about other voters' preferences. I find that Condorcet-consistent rules are most resistant to strategic voting, followed by elimination procedures and the simplest voting rules. The voting results can be more easily manipulated, the smaller is the size of the committee and the more voting alternatives are considered. I find that a minimal reduction in strategic voter's information about other voters' preferences severely inhibits the possibility of strategic voting."
