Director:

The director became actively involved in the ongoing reform of R&D financing in the Czech Republic. Specifically, he served on the Expert Committee for Humanities and Social Sciences at the Research and Development Council (RDC) of the Czech Government and on the Expert steering committee of an IPn EU-funded international audit of Czech research evaluation. He also represented EI in the Executive Committee of the European Association of Labour Economists and in the Managing Board of the Czech Economic Society and served as chair of the Economics Panel at the Czech Science Foundation as well as chair of the Social Sciences and Humanities Committee of the same agency.

El Board:

The EI Board's meeting dates for 2009 were February 6, June 5, September 14, and November 24.

A selection of the substantive issues discussed during its meetings appears below:

- The approval of the EI budget for 2009,

- The discussion and support of the nominations of the EI candidates for the new review panels of Czech Science Foundation (GACR).

The minutes from the EI Board meetings are available on the internal website.

Supervisory Board:

The Supervisory Board was nominated during the 30th meeting of the Academic Council on March 27, 2007.

The Supervisory Board's meeting dates for 2009 were March 23, June 26 and November 24.

During its meetings, the Supervisory Board commented on the proposal for the EI annual report for 2008, acknowledged the proposal for the EI budget for 2009 and after this also acknowledged a report on the drawing up of the budget and the auditor's report including the management letter. The Board also approved with minor comments the proposed text of the joint workplace agreement with Charles University, CERGE. Hereafter the Board evaluated the managerial skills of the El Director and expressed its prior consent to make a long-term rental contract. At its last meeting of 2009 the Board appointed an auditor for financial management for 2009 and 2010 and approved the acceptance of an appendix to the Foundation Deed concerning other activities of the workplace.

II. Information on the modification of the Foundation Deed

There were no modifications to the Foundation Deed during the year 2009.

III. Evaluation of the main research activities

The main research activity of the Economics Institute of the ASCR, v. v. i. (EI) is determined by the institutional research program, which is related to almost all major fields of modern theoretical and empirical economics.

In basic macroeconomic research in 2009, the global economic and financial crisis has raised the question of the importance of real estate markets and the identification of bubbles. Bursting bubbles can have a large negative impact on an economy. Mikhed and Zemčík (*Journal of Real Estate Finance and Economics*) construct a bubble indicator using panel data on house prices and rents. Mikhed and Zemčík (*Journal of Housing Economics*) generalize this methodology using other factors affecting housing prices such as income, stock market wealth and population. Both studies identify a bubble on the US market prior to 2007.

In economic terms, terrorist attacks can also negatively affect any economic system and it is useful to know their major predictors. Krueger and Malečková (*Science*) investigate the impact of a country's public opinion of the government in another country on the number of terrorist attacks in that country. They find that disapproval of the leadership in a country increases the incidence of terrorist attacks in the country.

The second important part of our research agenda involved an investigation of firm profitability. In this line of research we evaluate what we have learned to date about the effects of privatization (see Estrin, Hanousek, Kočenda and Švejnar, *Journal of Economic Literature*). As judged by efficiency, profitability, revenues and other indicators, the effect of privatization is mostly positive in Central Europe. However, the positive effect is quantitatively smaller for Central European countries than it is for foreign owners of companies in Central Europe, and larger in the later transition period than it was in the earlier period. In the Commonwealth of Independent States, privatization to foreign owners yields a positive or insignificant effect. The available papers on China find diverse results, with the effect of nonstate ownership on total factor productivity being mostly positive but sometimes insignificant or negative.

Another crucial part of the institutional research plan for El is a detailed theoretical and empirical analysis of human capital. Jurajda and Paligorova (*Labor Economics*) examine the gender gaps in employment and wages among top- and lower-level managerial employees in a post-communist country, the Czech Republic, at the time of its accession to the EU. They find the representation of women at the top level of management of Czech firms as well as the structure of the gender wage gap are quite similar to those in the US. Jurajda and Terrell (*Economics of Transition*) show that large and persistent differences in regional unemployment in post-communist economies are largely due to regional variation in inherited human capital. A list of all publications is given in Appendix A.

Some of the research activities conducted by EI have direct policy implications. In 2009, EI actively participated in important discussions whose results were presented in the form of written expert studies. EI researchers for example prepared a referee report for the OECD regarding career advice given in the Czech education system. They also contributed to the ongoing debate on the evaluation of research and development for the Council of the Czech Government for Research and Development. Specifically, they analyzed the redistribution of institutional funds to scientific organizations based on the newly adopted methodology of evaluating research output and also based on long-term directions of applied research in the Czech Republic. In addition, our employees prepared a detailed analysis of the socalled White Book of Research, Development and Innovation in the Czech Republic for the Czech Ministry of Education, Youth, and Sports. We also studied the relocation of production factories among countries and its impact on employment, wages, and development. This study was conducted for the European Commission.

Other research questions were investigated based on consulting contracts. With our help, our partner organization OG Research s.r.o. created prediction models of reference interest rates and exchange rates in Cambodia, Guatemala and Rwanda for TCX Management Company. We also revised the methodology of the evaluation of the impact of investment incentives. The revision was completed on behalf of Deloitte Advisory s.r.o. and it included updating transaction and employment multipliers for regions of the Czech Republic from 1998 to 2008.

El cooperates closely with the Center for Economic Research and Graduate Education (CERGE), within a joint workplace called CERGE-EI (without a joint legal statute). The joint workplace puts strong emphasis on the quality of research. To keep the high level of researchers, we hire promising candidates on the international academic market. In 2009, we hired a graduate of the University of Chicago. From an organizational perspective, we would like to stress the continuing involvement of young researchers and doctoral students in the research activities of EI. This is especially the case within the framework of the Center of Advanced Political Economy Research (CAPER, project code LC542), established in 2005 with the objective of fostering the professional careers of young researchers. The Center is supported within the program of basic research centers of the Czech Ministry of Education, Youth, and Sports. CAPER is a steady source of high quality research papers on policy-related questions. The existence of CAPER made it possible in the past to double the number of full-time contracts for advanced doctoral students and post-doctoral researchers employed as Junior Researchers at CERGE-EI. The financial support for this Center has been extended to 2010.

The outcomes of the research cooperation of EI with CERGE within CAPER include articles published in top refereed impact factor journals, see Kováč and Mylovanov (Journal of Economic Theory) and Rydval, Ortmann and Ostatnický (Journal of Economic Behavior & Organization). The former paper analyzes the relative performance of stochastic and deterministic mechanisms in an environment that has been extensively studied in the literature on communication and optimal delegation: a principal-agent model with hidden information, no monetary transfers and single-peaked preferences. The authors show that the optimal mechanism is deterministic. The latter paper studies experimentally the nature of dominance violations in three minimalist dominance-solvable guessing games, also known as beauty contests. These games are useful for ex ante studies of rationality without altruism and risk aversion. Nearly two-thirds of subjects reason inconsistently with dominance, yet a quarter of them actually make dominant choices and half of those expect others to do so. Reasoning errors are more likely for subjects with a lower ability to maintain and allocate attention, as measured by working memory, and for subjects with lower intrinsic motivation and premeditation attitude.

El and CERGE also cooperate in educating young researchers at the outset of their scientific careers, both within the framework Center LC542 and otherwise. The CERGE-El Ph.D. program in Economics is accredited in the Czech Republic and permanently fully accredited in the United States. This type of a doctoral program is modeled on programs in the US and usually lasts from 5 to 6 years, which is longer than similar local programs. CERGE-El graduates have been very successful in finding jobs in high-quality Czech and foreign research institutions. For instance, J. Stančík received a research scholarship at the Institute for Prospective Technological Studies, which operates within a joint research center of the European Commission. Many of our employees worked abroad on short research stays at top foreign universities and research centers. D. Kowalczyk participated in a research project at the European Central Bank, Y. Rychalovska was at the National Bank of Belgium, I. Maci was at the University of California, Berkeley and F. Pertold was at the University of Illinois at Chicago.

The international cooperation of EI has several layers. First, our researchers cooperated with various European institutions within the framework of grants from the European Commission. In 2009, we continued our work on important grants within the 7th Framework Program. Š. Jurajda leads the project Intangible Capital and Innovations: Drivers of Growth and Location in the EU (INNODRIVE) and R. Boháček was in charge of Employment and Health at 50+: A Life History Approach to European Welfare State Interventions (SHARELIFE). Another project is *A New Agenda for European Security Economics* (EUSECON) led by J. Malečková. L. Lízal leads our effort on a newly acquired project *Finance, Innovation, and Inequality* (FINNOV). European institutions involved in these grants include for example the University of Cambridge in the United Kingdom, the Saint Anna School of Advanced Studies in Italy or the University of Bordeaux in France.

Second, we successfully continue working on other previously acquired grants of various types, for instance *Dynamics of Institutions and Markets in Europe* (DIME) and *Reflexive Governance in the Public Interest* (REFGOV). Detailed information about all grants and researched projects of the European Commission is available in Appendix B. Finally, our Junior Researchers participated in the research program of the Global Development Network, which was previously financed by the World Bank. Interesting projects in this group of grants include *Financial Sector Development and Dollarization in the Economies of Central Asia* by A. Isak and *Risk Aversion of Betfair Bettors* by F. Kopřiva.

El continued to host a variety of meetings and conferences with the participation of top foreign researchers in economics. These include the Annual Conference of the Global Development Network. Top specialists presented the results of their current research projects. In 2009, El organized one scientific conference and free workshops within the joint workplace CERGE-El. El employees lectured at 130 conferences, workshops and seminars both in the Czech Republic and abroad, 46 of which were presentations by invitation. Our institute also participated in the popularization of economic science. Besides the above-mentioned conferences, El organized 59 seminars in three seminar series in the fields of macroeconomics, microeconomics and applied microeconomics. These seminars enabled local specialists to follow recent advances in their fields. In addition, there were 6 lectures and special occasion meetings for the general public including round table discussions, 7 seminars and panel discussions regarding healthcare, 3 lectures in a discussion series for the Association for International Affairs (AIA), and 3 public lectures for external visitors.

The work of our researchers has been closely followed by the Czech scientific community. Our researchers significantly contribute to the work of all important local grant agencies. E. Kočenda received the Prize of the President of the Czech Science

Foundation and F. Kopřiva became the Young Economist of the Year 2009, an award given by the Czech Economic Society. The CERGE-EI joint workplace puts strong emphasis on the quality of research. CERGE-EI dominates in the Czech Republic based on publications in international journals with an impact factor in the fields of Economics and Finance from 2005 to 2008 (a detailed comparison for 2009 is not yet available). Therefore it is not surprising that CERGE-EI has been repeatedly ranked as the best economics research organization in the country by a large margin. This is also reflected in the point evaluation according to the new methodology of the evaluation of research output used by Czech institutions.

The appendixes contain important information that further characterizes the activities of EI in 2009.

III.a. Public presentation of the workplace and the popularization of science

The workplace publicizes its activities, including seminars and publications, on its websites. Each year the workplace participates in the promotional activities of the Czech Academy of Sciences. During the ninth year of Science and Technology Week the workplace was open to both the scientific and general public and contributed to the program with a lecture on topic "Where Does Economics Begin and Where Does It End?".

El researchers are actively involved in popularizing economic science among the general public in the Czech Republic. They contribute to current public policy debates with their expert opinions in popular articles and interviews or by participating in expert government committees. During 2009 El researchers contributed 31 articles in the printed media and had almost 400 other appearances in the mass media.

The workplace held an Open Day on November 23, 2009 as a way to acquaint university students and media representatives with its activities. The Ph.D. program in Economics, which EI runs jointly with CERGE at Charles University, was introduced to prospective students not only from the Czech Republic but also from foreign countries.

Along with the main activities, the institute also performed other activities in 2009, including the following:

1. Education courses

The institute in cooperation with the Faculty of Humanities of Charles University in Prague carried out, as every year, the Spring and Fall semesters of UPCES (the Undergraduate Program in Central European Studies). Classes are made up mainly of American B.A. students, but the course is open also to students of Charles University and for students of the Erasmus program. The participants in the program study basic questions and problems related to the Central European region.

The institute also organized summer courses for American students from Richmond University in 2009.

2. Conferences and seminars

In 2009, the institute organized the "GDN/CERGE-EI Regional Research Competition Conference" (August 10-11, 2008) and the workshop "The Role of OFDI from Visegrad Countries in Strengthening Regional Integration" (December 4). The institute as a co-organizer participated in the following events: SHARE WORKSHOP (January 29)

All the above-mentioned activities not only improve international cooperation in economic research, but they are also an effort to use the knowledge of researchers to solve problems both on the governmental level and within the private sector in the Czech Republic.

IV. Information about the precautions for the elimination of defects in management and a report on how the precautions for the elimination of defects in management were fulfilled in the previous year

The institute's budget undergoes a financial audit annually. The auditor from HZ Praha, spol, s.r.o. had no complaints about the budgets for the year 2008, and therefore there was no reason to implement any precautions to remove deficiencies in the year 2009.

In August 2009, members of the monitoring department of the Academy of Sciences of the Czech Republic performed an inspection to see if the precautions from the year 2008 were being successfully implemented. According to the inspection, errors in the evidence of assets and the social accounting of the General Reserve Fund were found. Before the inspection, specific evidence of the substandard work performance of certain employees led to steps being taken. The Head Accountant of the institute was issued a written warning on May 29, 2009, and following that was released from employment on July 20, 2009. A decision was made not to prolong the contract of the Head of THS, whose contract was to be prolonged in February 2010. The Deputy Director for Finance was also responsible for the situation, and therefore was penalized by reducing his personal bonus by 50% for 3 months.

V. Financial information about facts that are important for the economic position of the institute and that can have an influence on its further development^{*}

Included in the annual report is the annual balance sheet for the year 2009 (see the attachment). According to the balance sheet, budgetary processes had no difficulties and shows positive income. This is the case even though this year there was a decrease in income from rent because now the Institute of Psychology of the Academy of Sciences of the Czech Republic, v.v.i. uses the first floor of the building for free.

VI. Expected development of institutional activities^{*}

In 2009 the contribution of the Academy of Sciences of the Czech Republic formed 67.2% of the total annual cost of the institute. Other costs were covered mainly by special purpose funds for science and research (Research Centre LC 542, grants of GA CR and GA AV, projects included in 6th and 7th RP, etc.). The remaining funds were secured by other activities within the main activities of the institute (see Part III.). We consider it important to note that in 2009 institutional support was allocated by the Ministry of Education, Youth and Sports of CR to three projects under 7th RP totaling 446 thousand CZK. This support should be allocated for the full duration of the projects, i.e. up to 2012. Since 2009 the institute has been dealing with a fourth project within the 7th RP. An important fact in the financing of the institute is that the project of Research Centre LC 542 has been extended until 2010. We believe that the current composition of the finances needed for the operation of the institute is satisfactory and gives a good basis for smooth operation in the future. This is especially the case if the Research Centers LC are extended, for they are an important source of financing for fostering the emerging scientific careers of Ph.D. students and recent graduates of the institute.

The institute should continue to be very active in raising special funds for the financing of science and research from domestic and foreign grant agencies. The findings of the current year shows that with a proper PR policy for the institute it is realistic to gain in the following period more contracts for expert studies within the private sector or at the government level.

INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying financial statements of the Economics Institute of the Academy of Sciences in the Czech Republic, which comprise the balance sheet as of 31st December 2009, and the income statement for the year then ended, and a summary of significant accounting policies.

Statutory Body's Responsibility for the Financial Statements

The Statutory Body of the Economics Institute of the Academy of Sciences in the Czech Republic is responsible for the preparation and fair presentation of these financial statements in accordance with Czech accounting regulations. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Act on Auditors and International Standards on Auditing and the related application guidelines issued by the Chamber of Auditors of the Czech Republic. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the



circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements give a true and fair view of the financial position of the Economics Institute of the Academy of Sciences in the Czech Republic as of 31st December 2009, and of its financial performance and its cash flows for the year then ended in accordance with Czech accounting regulations.
