### Austria's housing policy


- Beginning of the 20th century:

  - "barrier-free building"
- 2009:
  - 815 000 charitable buildings

Figure 1: Structure of Austrian housing stock (main residents, 2001)





- Nursing level 1: 154,20 €
  - ✓ more than 50 hours per month
- Nursing level 2: 284,30 €
  - ✓ more than 75 hours per month
- Nursing level 3: 442,90 €
  - ✓ more than 120 hours per month
- Nursing level 4: 664,30 €
  - ✓ more than 160 hours per month





### **Care allowance**

- Nursing level 5: 902,30 €
  - ✓ more than 180 hours per month
  - ✓ need for extraordinary investment into care is essential
- Nursing level 6: 1 242,00 €
  - ✓ more than 180 hours per month
  - √ care during day and night is necessary
- Nursing level 7: 1 655,80 €
  - ✓ more than 180 hours per month
  - ✓ absence of the functionality of extremities

### **Community building:**

### "Lebensoase"

- Individually planned care depending on individual needs of people
- Information and consultation considering personal problems and wishes
- Organization of external services
- Shopping-services on demand
- Wellness-spa
- Leisure time facilities





## Housing accessibility: Home emergency call system



- Pushing the alarm-button
- Assembling a connection to the control center
- Introduction of necessary measures





### Housing affordability:

### Subsidies in 24-hour care

- Problem:
- Violation of many legal provisions (illegal employment of nursing staff etc.)
- High costs of 24-hour-care
- In 2007: Development of a new model
- Since 2008:
- Nursing staff is allowed to take more actions
- Subsidies in 24-hour-care





### Social and health care: ELGA – Electronical health document

- Developed by the ELGA GmbH in 2009
- Financed by federation, states and social insurance
- Guarantee for a better treatment and more safety
- Listing of health-documents in a common register
- Ability of subsequent treatment organization to use the data and documents
- Patient is able to access the dates





## Access to information/ education: Info-TV

- Integrated TV in all flats and rooms of the Samaritan nursing homes
- Samaritan-own Info-channel
- Possibility for residents to watch important information, upcoming activities, pictures (about past activities, trips or festivities)
- Aim: to broaden and expand the offer to maintain and advocate the residents' existing resources and mental abilities
