# **TENDER DOCUMENTATION**

This tender documentation (hereinafter the "TD") forms a basis for preparation of bids in open procedure seeking public contract for supplies pursuant to the Act. The rights, obligations and terms and conditions stipulated herein are governed by the Act.

## 1 DEFINITION OF THE SUBJECT-MATTER OF THE PUBLIC CONTRACT

### 1.1 Classification of the subject matter of the public contract

Classification of this public contract corresponds to items:

• CPV code: 38514200-3 – scanning probe microscopes

CPV code: 33114000-2 - spectroscopic devices

• CPV code: 38636100-3 - lasers





**Type of public contract:** above-threshold public contract for supplies

Type of procurement procedure: open procedure

## 1.2 Description of the subject matter of the public contract

The subject matter of this public contract is supply (acquisition) of a **Terahertz (THz) time-domain scanning near-field microscope (SNOM) device**. The device must use ultrashort broadband THz pulses and allow nanoscale THz conductivity imaging and spectroscopy and nanoscale ultrafast THz photo-conductivity imaging and spectroscopy (i.e. the system must enable time-resolved optical pump—near field THz probe experiments). More detailed specification of the subject matter is provided in Chapter 4 below.

To the best of our knowledge a fully commercial instrument allowing optical pump—near field THz probe experiments with picosecond time resolution is not currently available on the market. In chapter 4 we provide requirements for a technical solution that requires a relatively small development effort on the customer side consisting in the introduction of the optical pump into otherwise fully functional device. If the bidder proposes another technical solution, the tender application must show that the above-mentioned experiments can really be performed / developed within the proposed solution.

Anticipated commencement: immediately after contract conclusion
Anticipated completion: within 5 months of contract conclusion

### 1.4 Place of Performance

Place of performance shall be the premises of the Fyzikální ústav AV ČR, v. v. i. (Institute of Physics AS CR), at Na Slovance 1999/2, 182 21 Praha 8, room No. 63

## 1.5 Estimated value

Estimated value of the public contract is 11 500 000 CZK excl. VAT.

The contracting authority, whose main activity is research and development in the field of physical sciences, is the beneficiary of the subsidy for the project "Solid state physics for the 21st century", Registry No CZ.02.1.01/0.0/0.0/16\_019/0000760, within the Operational Program Research, Development and Education (OP RDE). The subject of public procurement will be co-financed by the EU Structural Funds.

# 2 CONDITIONS AND REQUIREMENTS REGARDING THE DRAWING UP OF A BID

- 2.1 Bids shall be submitted in electronic form only using the Tenderarena electronic tool within the time limit for the submission of bids. Bids in paper form are not permitted.
- 2.2 Bids shall be submitted no later than on **3<sup>rd</sup> December 2018** by **11:00 am**. Other methods of delivery shall not be considered to constitute a properly delivered bid.
- 2.3 The electronic tool eGORDION v. 3.3 Tender arena (hereinafter "**Tenderarena**") for the submission of the bid in electronic form is available at <a href="www.tenderarena.cz">www.tenderarena.cz</a>. Economic operators may find at this link also a guide for using the Tenderarena electronic tool (via link "Help" in footer) and helpdesk contacts.





- 2.4 The bidder must have a personal computer with a minimum of the following performance: CPU 1 GHz, 1024 MB memory, 20 GB hard drive, personal computer must be connected to the Internet at a minimum connection speed of 2 Mbps (DOWNLOAD) / 512 Kbps (UPLOAD), the entrant must have an Internet browser installed on your computer (Microsoft Internet Explorer version 9.0 or higher, Mozilla Firefox version 30.0 and above) that has Java SW version 1.8 and above installed.
- The bidder must be registered as a contractor in the Tenderarena for the submission of the bid; link "contractor's registration" ("registrace dodavatele" at <a href="www.tenderarena.cz">www.tenderarena.cz</a>). A user of the bidder must have a system role of a participant ("účastník zakázky"). Registration of the bidder takes up to 48 hours (on working days) after all required documents have been submitted (either by post or electronically). Registration on Tenderarena electronic tool is not charged.
- 2.6 If a request to sign a specific document is included in this TD while not accepting the replacement of the document by its simple copy or scan, the individual documents constituting the content of the bid whose signing by a person authorized to represent a tenderer is required to be accompanied by an electronic signature based on a qualified certificate pursuant to Act No. 297/2016 Coll., on trust-building services for electronic transactions, as amended.
- 2.7 The Contracting authority points out that the Contracting authority bears no responsibility for any technical conditions on the economic operator's side. The Contracting authority recommends economic operators to consider especially the speed of their Internet connection when submitting bids so that bids are submitted within the time limit for submission of tenders. This means uploading all attachments of the bid and final submission of the bid to the Tenderarena electronic tool.
- 2.8 The bid may be prepared in the Czech or English language.
- 2.9 The bid must include **identification data of the bidder**, i.e. primarily: business name, registered office, identification number, legal form, persons authorized to act on behalf of / represent the bidder, contact details for correspondence.
- 2.10 The bid in electronic form shall not exceed 200 MB; of which a maximum of 100 MB are documents proving qualifications and a maximum of 100 MB are other documents provided in bids. The bid must be processed through acceptable file formats, ie Microsoft Office (Word, Excel), Open Office, PDF, JPEG, GIF, or PNG. The bid values as specified in this TD will also be submitted to the tendering procedure by inserting them into the tender form, which will be displayed when submitting the tender in electronic form. This is without prejudice to the obligation to submit other tender documents containing the bid.
- 2.11 For the submission of bids in electronic form the bids must be encrypted with a certificate provided at the Tenderarena electronic tool; the certificate is attached to the Procurement Documentation at <a href="www.tenderarena.cz">www.tenderarena.cz</a>. In the case of encryption with other certificates, such a bid will be considered not delivered to the Contracting authority in the manner laid down in this Procurement Documentation and such a bid will not be considered as submitted to the Contracting authority. The <a href="bid">bid</a> encryption with a certificate is carried out automatically in the Tenderarena electronic tool <a href="before the bid">before the bid is submitted to the Tenderarena electronic tool using public certificate provided by the Contracting authority.">www.tenderarena.cz</a>.
- 2.12 Detailed information on the registration to Tenderarena electronic tool are attached hereto as an **Annex No. 4 Registration to the system Tender arena** (detailed





information on the registration to Tenderarena electronic tool are also available at <a href="https://www.tenderarena.cz">www.tenderarena.cz</a>).

- 2.13 Where several bidders jointly participate in a tendering procedure the bidders will also include in the bid the identification of the person who shall be authorized to represent the bidder in contact with the Contracting Authority during the award procedure.
- 2.14 The contracting authority does not specify the award period for this award procedure.
- 2.15 The bid must be submitted in the following structure:
  - a) Cover sheet (please refer to Annex No. 1 hereto);
  - b) documents proving fulfilment of the qualification in the structure as set out in Article 3 of the TD and description and specification of the performance offered demonstrating that the Contracting Authority's requirements regarding subject matter of the contract are met; all documents proving fulfilment of the qualification may be presented in a plain copy or scans OR bidders may substitute the submission of documents proving fulfilment of the qualification by an affirmation or by the European Single Procurement Document;
  - c) statement defining the bid price in the structure according to Article 0 hereof;
  - d) the data relevant for the performance of the assessment under Chapter 7 of this TD;
  - e) draft contract (please refer to Annex No. 3 hereto).

## **3 QUALIFICATIONS**

- 3.1 Qualification requirements shall be met by those bidders who will demonstrate:
  - a) fulfilment of basic qualification pursuant to Section 74 of the Act,
  - b) fulfilment of the professional qualification pursuant to Section 77 paragraph (1) of the Act,

All documents proving fulfilment of the qualification may be presented in a plain copy or scans OR bidders may substitute the submission of documents proving fulfilment of the qualification by an affirmation or by the European Single Procurement Document.

#### 3.2 **Basic qualification**

- 3.2.1 Basic qualification shall **not** be met by bidder who:
  - a) was convicted by final judgement in the country of its registered seat of a crime specified in Annex No. 3 to the Act or another similar crime pursuant to the law of the country of its registered office in the past five years preceding the commencement of the procurement procedure; expunged convictions are disregarded,
  - b) has outstanding tax arrears registered in tax records in the Czech Republic or in the country of its registered office,
  - c) has outstanding arrears in respect of payments and penalties of public health insurance in the Czech Republic or in the country of its registered office,
  - d) has outstanding arrears in respect of payments and penalties of social security contributions and contribution to the national employment policy in the Czech Republic or in the country of its registered office,





- e) is in liquidation, has been declared insolvent, in respect of whom the receivership has been imposed under another legal regulation or it is in a similar situation pursuant to the law of the country of its registered office.
- 3.2.2 Bidders shall prove fulfilment of the basic qualification in relation to the Czech Republic by submitting:
  - a) a copy of an entry in the Criminal Records in respect of Section 74 paragraph (1) point a) of the Act (from the country of residence),
  - b) a confirmation from a relevant tax office in respect of Section 74 paragraph (1) point b) of the Act (from the country of residence and Czech Republic),
  - a written affirmation regarding excise duty in respect of Section 74 paragraph (1) point
     b) of the Act,
  - d) a written affirmation in respect of Section 74 paragraph (1) point c),
  - e) a confirmation from a relevant district social security administration in respect of Section 74 paragraph (1) point d) of the Act (from the country of residence and Czech Republic),
  - f) a copy of an entry in the Commercial Register, or a written affirmation in the event that the economic operator is not incorporated in the Commercial Register, in respect of Section 74 paragraph (1) point e) of the Act.
- 3.2.3 If the bidder is a legal person, both this legal person and every member of its governing body shall meet the condition specified in paragraph 3.2.1 point a). Where a legal person is a member of the governing body of the bidder, the condition specified in paragraph 3.2.1 point a) shall be met by
  - a) this legal person,
  - b) every member of the governing body of this legal person and
  - c) the person representing this legal person in the governing body of the bidder.
- 3.2.4 If the bidder is a branch of a business of
  - a) a foreign legal person, the condition specified in paragraph 3.2.1 point a) shall be met by this legal person as well as the head of the branch.
  - b) a Czech legal person, the condition specified in paragraph 3.2.1 point a) shall be met by the persons referred to in paragraph 3.2.3 as well as the head of the branch.

#### 3.3 **Professional qualification**

- 3.3.1 Bidders shall prove fulfilment of the professional qualification in relation to the Czech Republic by submitting a copy of an entry in the Commercial Register or other similar records provided that registration in such records is required pursuant to another legal regulation.
- 3.3.2 The bidder is not obliged to submit the document specified in paragraph 3.3.1 if legal regulations in the country of its registered office do not require such professional qualification.





### 3.4 **Technical qualification**

3.4.1 The bidder is obliged to demonstrate fulfilment of technical qualification pursuant to Section 79 paragraph (2) point b) of the Act. Fulfilment of the technical qualification will be demonstrated by a bidder, who submits a list of significant supplies provided over the past three years before the commencement of the procurement procedure. This list will contain information on the name of the client, supply name, place and date of completion and the financial value of the supply. A major supply shall be considered as a supply of an optical microscope for near-field measurements in the THz spectral range using picosecond broadband THz pulses with financial value of at least 7 000 000,- CZK excl. VAT. Bidders shall demonstrate the supply of at least 2 such major supplies.

# 4 DETAILED DESCRIPTION AND TECHNICAL SPECIFICATION OF THE SUBJECT MATTER

- 4.1 The subject matter of this public contract is fully specified in Annexes No. 1 and 2 of the draft contract which forms an integral part hereof as Annex No. 3 hereof.
- 4.2 All equipment, which shall form a part of the subject matter must comply with all requirements arising from technical or safety standards valid in the Czech Republic for these types of equipment. Performance required hereunder shall include handover of complete documentation to the equipment. The Contracting Authority requires that the entire subject matter and all its parts will be new, not re-used.
- 4.3 The TD specifies the minimum technical requirements in Annex No. 1 of the draft contract. It is permitted that bidders supply the same or higher level solution, than those described in the technical specification, but it must always comply with the minimum requirements as set forth herein. The bidder must describe the procedure of his site acceptance tests (SAT) of the device and include SAT representative results in the tender application.
- 4.4 Bidders must always comply with technical requirements stipulated herein; should a bidder fail to comply with these he shall be excluded from further proceedings. Bidders are obliged to prove guaranteed technical parameters to the Contracting Authority as specified herein, i.e. bidders shall submit detailed technical specification of the offered solution containing at least the best achievable parameters, which must demonstrate compliance with the minimum technical parameters specified in Annex No. 1 to the contract in the Czech or English language (other language mutations will not be admissible). Specified parameters must be achieved also during installation of the equipment in the place of performance. The submitted documentation shall form a part of Annex No. 2 to draft contract.
- 4.5 Should this TD refer to specific commercial trademarks / products or solution, or other designations or visual presentations having relation to a specific supplier / manufacturer, it shall be understood as delineation of an anticipated characteristics and the bidder are entitled to propose other technically or qualitatively compliant solution.





#### 5 STRUCTURE OF THE BID PRICE

- 5.1 Bidders are obliged to specify the total offered bid price, including all required performance; the total offered bid price to be quoted in **CZK excl. VAT**.
- 5.2 The total bid price must include the entire subject matter and will represent a fixed, binding amount as the maximum amount and maximum admissible price, including all fees and other costs that may be associated with the performance provided hereunder, such as transportation to the place of performance, packaging, custom duties, assembly and installation costs, insurance cost etc.
- 5.3 The bid price may be exceeded exclusively in connection with the change of tax legislation related to mandatory VAT, by an amount corresponding to this legislative amendment only.

## 6 TERMS AND CONDITIONS, PAYMENT TERMS

- 6.1 Terms and Conditions and payment terms have been specified in the attached binding draft contract, which forms an integral part hereof as Annex No. 3 hereof.
- 6.2 Bidders are obliged to accept without reservation or change the text of the draft contract, which forms an integral part hereof as Annex No. 3. Bidders are authorized to fill in their identification data, the bid price and other clearly marked information that are to be filled in. Bidders are not authorized to change or add to the contract in any manner, with exception of those parts which the Contracting Authority highlighted. Any breach of this condition will result in exclusion of the bidder from the procurement procedure.

## 7 EVALUATION CRITERIA

- 7.1 The bids will be evaluated on the basis of their economic advantageousness.
- 7.2 The partial evaluation criteria are:

7.2.1	Total bid price	- 35 %
7.2.2	Duration of the warranty	- 5 %
7.2.3	Quality of the service under warranty	- 10 %
7.2.4	Technical level of devices	- 50 %

#### 7.3 The method of evaluation:

7.3.1 According to the partial evaluation criterion 7.2.1 the contracting authority will evaluate the total bid price in CZK without VAT, processed in accordance with Article 5 of the tender documentation. See the formula below:

 $Number\ of\ points = \frac{lowest\ tender\ price\ in\ CZK\ excl.\ VAT}{Bid\ price\ of\ the\ evaluated\ bid\ in\ CZK\ excl.\ VAT} \cdot 35$ 





7.3.2 According to the partial evaluation criterion 7.2.2 the contracting authority will evaluate the duration of the guarantee for quality throughout the months, with a minimum length of 12 months (a tender offering a lower guarantee duration than 12 months will be discarded). The contracting authority admits as a maximum guarantee of 36 months (if the contracting authority would offer a higher value, the contracting authority will not take into account the duration of the guarantee exceeding 36 months and will use 36 months for the purposes of the evaluation). See the formula below:

Number of points = 
$$\frac{\text{(Duration of the warranty in months of the rated bid} - 12)}{(36 - 12)} \cdot 5$$

7.3.3 According to the partial evaluation criterion 7.2.3 the contracting authority will evaluate the quality of the service under warranty using the following criteria: delay of the customer service response on system failure/problem; assistance and speed for fast diagnostics of the problem; guaranteed delay of the on-site intervention; availability of the service in the Czech Republic or in EU.

The applications will be ordered following the warranty service quality. 100 points are attributed to the first application; the point value of each subsequent application is progressively lowered by 10 points. This value is finally multiplied by 0.1 corresponding to the weight (10%) of the 7.2.3 criterion.

7.3.4 According to the partial evaluation criterion 7.2.4 the contracting authority will evaluate the technical level of devices using the following criteria: resolution of the SNOM; technical level of incorporation of THz time-domain setup to AFM; SNR and acquisition rate of the SNOM in the THz range; readiness of the device to be extended to pump-probe experiments.

The tender applications will be ordered following the technical level of the device. 100 points are attributed to the first application; the point value of each subsequent application is progressively lowered by 10 points. This value is finally multiplied by 0.5 corresponding to the weight (50%) of the 7.2.4 criterion.

## 8 ADDITIONAL REQUIREMENTS AND CONDITIONS

- 8.1 The Contracting Authority reserves the right to verify any information provided by bidders using third parties, and bidders shall be obliged to provide the Contracting Authority all necessary cooperation in this matter.
- 8.2 Bidders shall bear the cost of processing their bids.
- 8.3 The Contracting Authority reserves the right to alter or amend the TD before the deadline for submission of bids, such a change would be communicated to all bidders who on the date of such amendment submitted a bid. The change of the TD would be announced also in the manner in which the TD was published. If the nature of the supplement or amendment of the TD requires, the Contracting Authority simultaneously reasonably extends the deadline for submitting bids.





- 8.4 The Contracting Authority reserves the right to publish the full outcome of the procurement procedure and to provide information under the Act No. 106/1999 Coll., on free access to information, eg. to allow access to the protocol on the opening of envelopes, the protocol on the evaluation of bids, and so on.

  However, according to Act on free access to information, the Contracting Authority will not grant:
  - a) until the completion of the procurement procedure information relating to the content of bids and the persons who are involved in during the procurement procedure,
  - b) information which the bidder has provided to the Contracting Authority within the procurement procedure and marked them as confidential unless it is information that in accordance with the Act the Contracting Authority has the obligation to include in the evaluation report, the notice of the selection of the supplier, the assessment of the fulfilment of conditions for participation of selected suppliers or in the written report by Contracting Authority.
- 8.5 The Contracting Authority reserves the right, after completion of the procurement procedure in the context of transparency, to publish on the Internet further defined range of information provided by the bidder during the procurement procedure and possibly during performance of the contract, including the information identified as confidential. These information are the following:
  - name of the bidder
  - · identification No. of the bidder
  - bid price of the bidder
  - · No. of the signed contract
  - name of the contract
  - · text of the contract including all annexes and amendments
  - the amount of price paid for performing the public contract
  - · list of subcontractors of the supplier of the public contract
- 8.6 Termination of public contract does not terminate the right of the Contracting Authority to publish the above information. Through its participation in the procurement procedure the bidder takes note that the above information provided during the procurement procedure will be treated as described above by the Contracting Authority. The bidder agrees with use of such information by submitting its bid.
- 8.7 The Contracting Authority reserves the right to cancel the procurement procedure according to Section 127 paragraph (2) of the Act. In case of cancellation of the procurement procedure the bidders are not entitled to any compensation for costs incurred in preparing the bid nor any other compensation.

# 9 OPENING OF THE BIDS

9.1 Opening of the envelopes with bids shall take place immediately after the expiry of the bid submission date referred to in paragraph 2.2 of the TD, at the seat of the Contracting Authority. The opening of the bids will take place electronically in accordance with Section 109 of the Act.

#### 10 CONCLUSION

10.1 Information and data provided herein (incl. all Annexes) defined the binding requirements





of the Contracting Authority with respect to the performance of the public contract. These requirements must be accepted by the bidders in full and without reservation, respecting these requirements in preparation of their bid. Non-acceptance of these requirements / conditions (incl. those specified in the respective Annexes) shall be deemed to constitute failure to comply with the tender conditions.

10.2 Should this tender documentation or its Annexes refer to specific commercial trademarks / products or solutions, or other designations or visual presentations having relation to a specific supplier / manufacturer, it shall be understood as delineation of an anticipated characteristics and the bidder are entitled to propose other technically or qualitatively fully compliant solution.
