Housing affordability, quality of life, and residential satisfaction in the Austrian cross-border suburban region of Bratislava, Slovakia

- Housing affordability in an area has stalled recently; in 2020, it even decreased
- A higher quality of life is related to the attributes of the residential environment
- Satisfactory residential environment impacts housing affordability
- At the same time, housing affordability influences the perceived quality of life
- Affordable housing seekers were more satisfied with their living and housing costs

Changeability of transport behaviour in a large city from the perspective of working days and Sundays: The case of Łódź, Poland

- Sunday retail restrictions and the pandemic have had impacts on travel behaviours
- Sunday trips have changed, as some people have completely stopped travelling
- A survey was conducted among 6,000 residents using mixed-mode techniques
- The results could be used to design city policies for sustainable urban mobility

Public transport accessibility and spatial exclusion in Roma settlements: A case study of three regions in Eastern Slovakia

- Public transport is an important means of mobility for poor Roma communities
- Access to public transportation in geographical reality is not perfect for all
- Segregated Roma communities usually have poorer access to transport networks
- Poor access to transport and services to regional centres may lead to social exclusion

- Markov transition probability matrices, stability and/or mobility over time
- Spatial structural change differs between the countries with policy relevance
